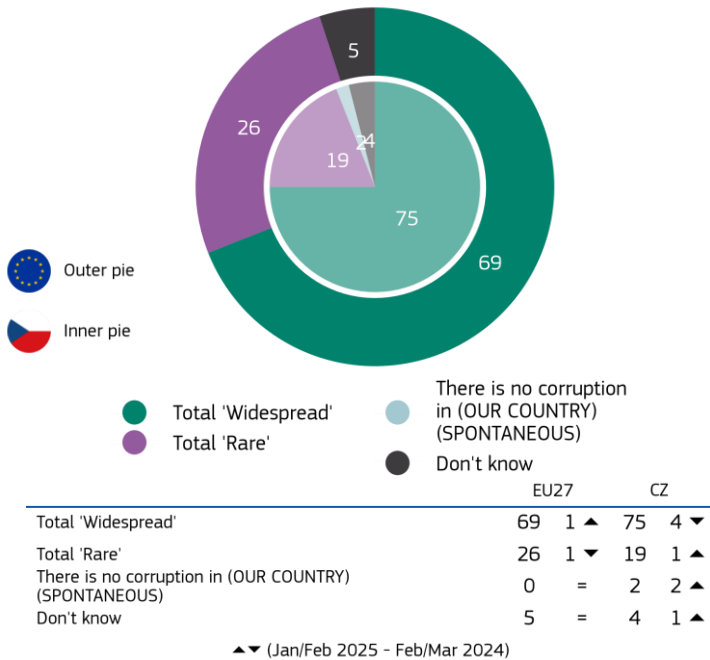

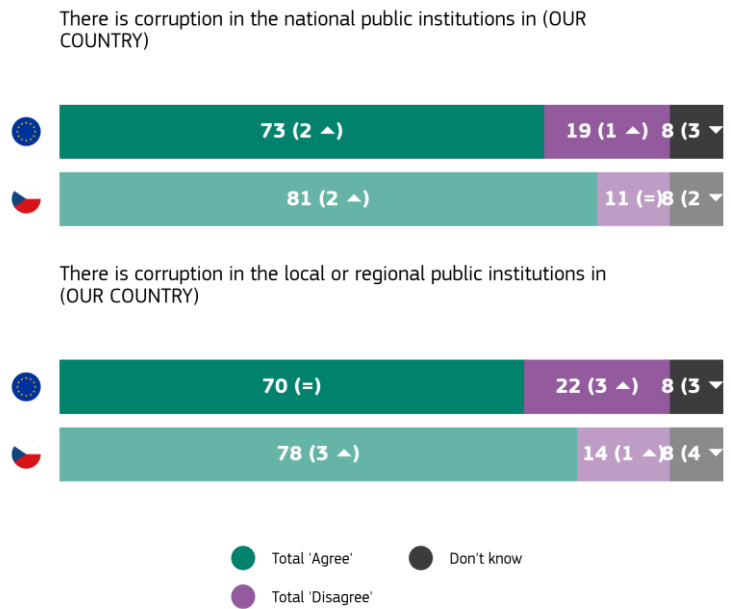

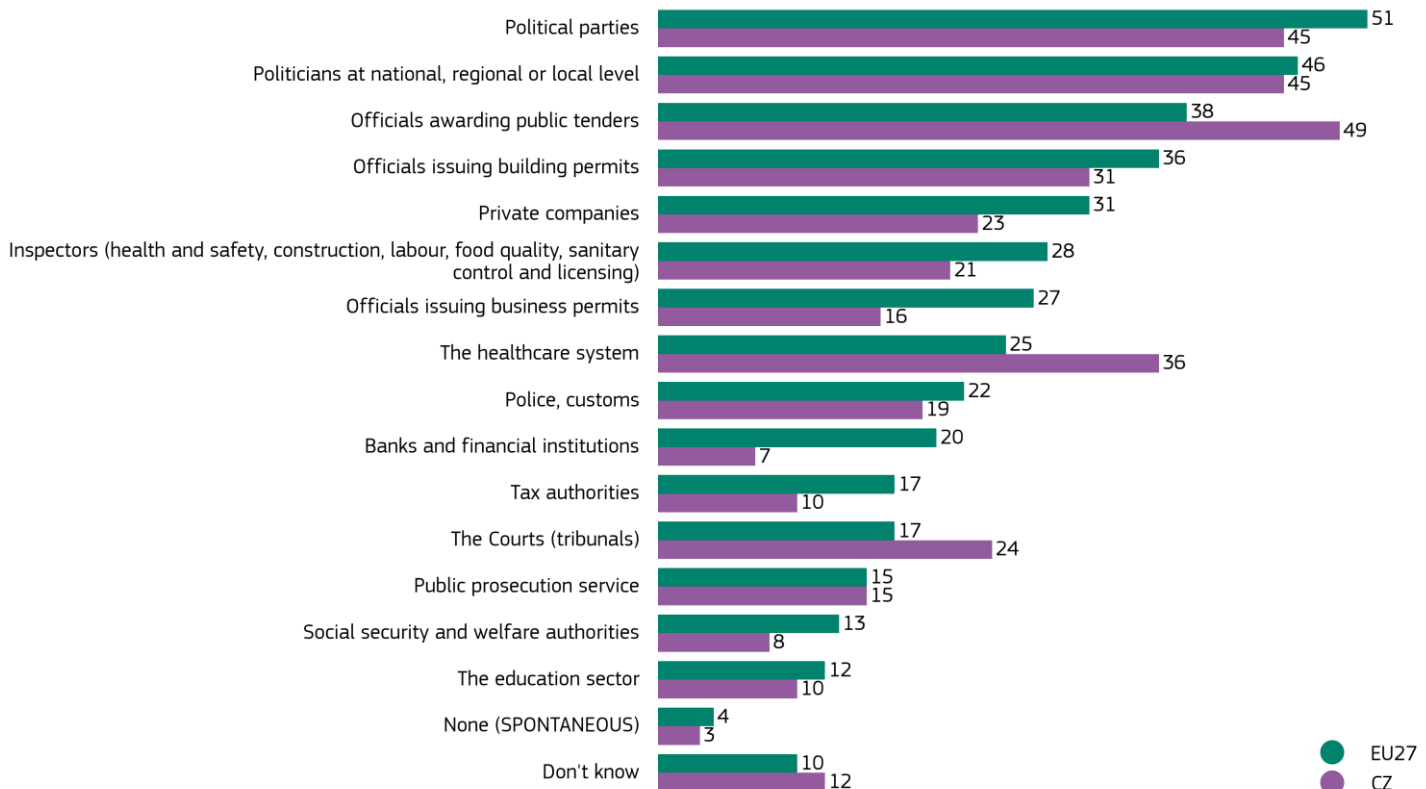
QD5. How widespread do you think the problem of corruption is in (OUR COUNTRY)? (%)

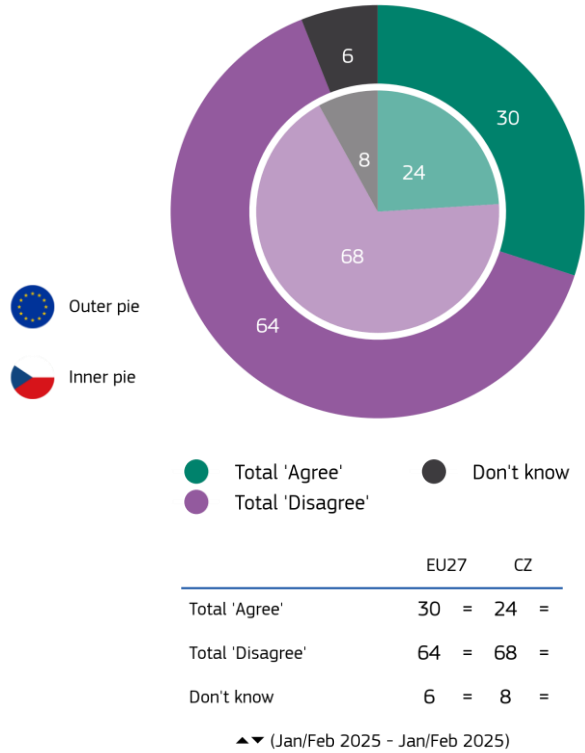

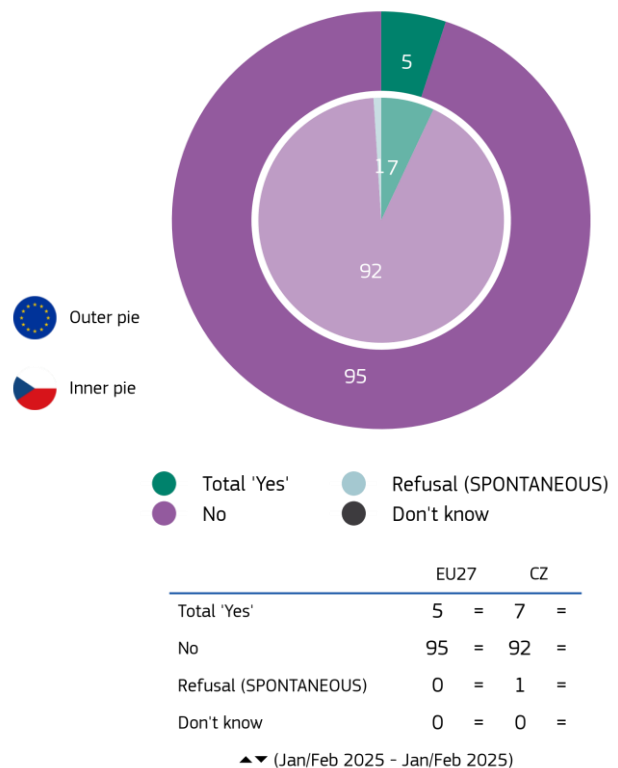

QD12a. In the last 12 months have you experienced or witnessed any case of corruption? (MULTIPLE ANSWERS POSSIBLE) (%)



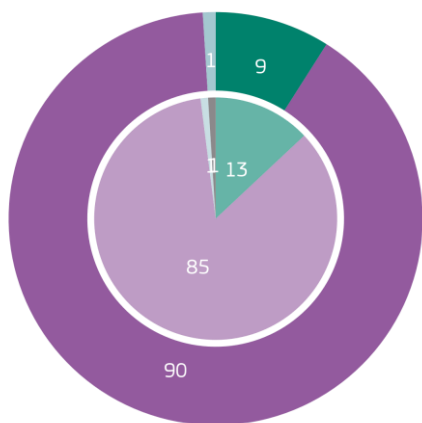

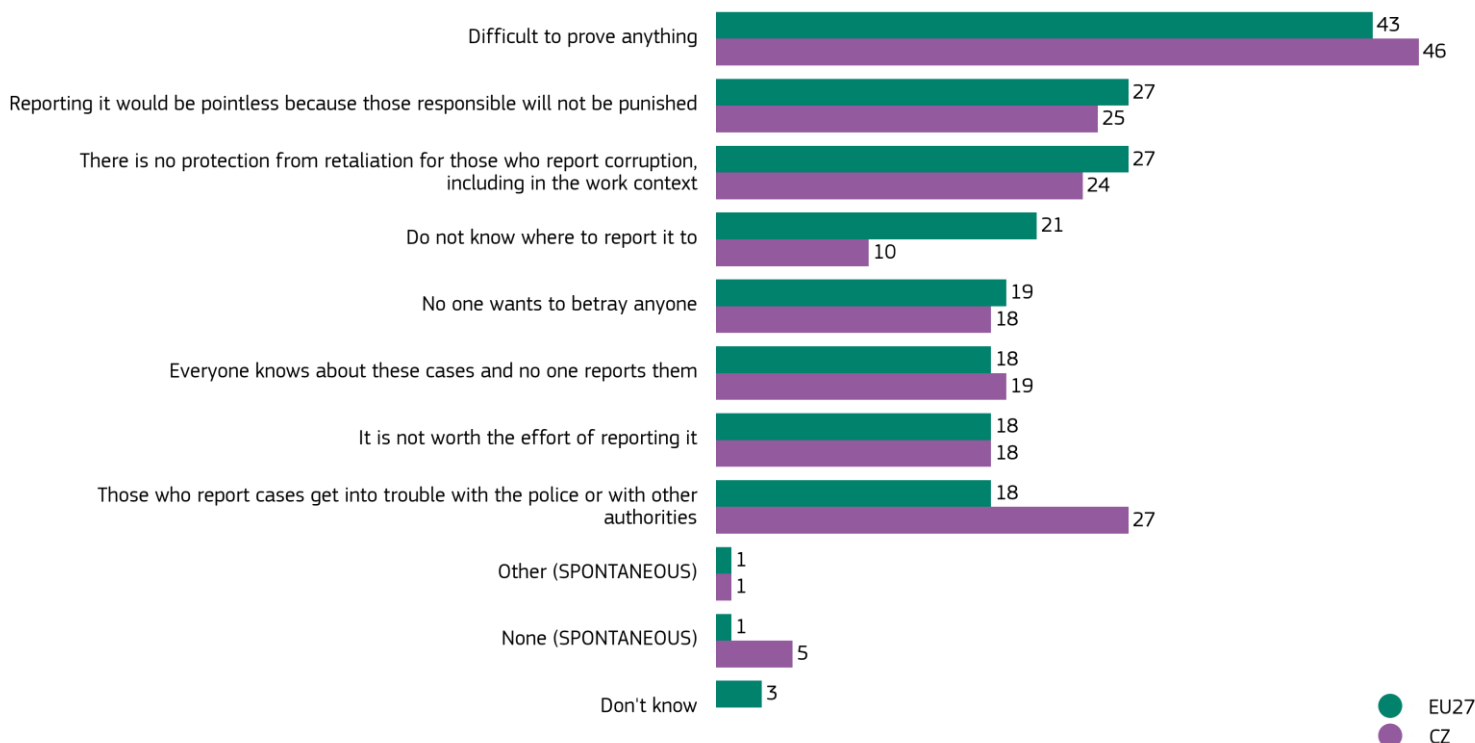
